

**Official Notice Regarding Unauthorized Use of
OWS Name – Suspected <OWS (SG) PTE LTD>**

Dear Esteemed Customers, Partners and Stakeholders,

We wish to bring to your attention a matter of significant concern involving an entity previously operating under the name "OWS (SG) PTE LTD"—which has since been renamed "ABYSS AI PTE LTD". This notice aims to clarify the non-affiliation of both entities with the OWS Group and safeguard the interests of all parties involved.

1. OWS Group Entity Clarification

We hereby affirm that the OWS Group currently does not possess any registered entity under the name "OWS (SG) PTE LTD," nor have we to date established or authorized any subsidiary, branch, representative office, or affiliate in Singapore. The aforementioned entity, whether operating under its former name "OWS (SG) PTE LTD" or its new name "ABYSS AI PTE LTD," is not associated with the OWS Group in any manner and holds no form of authorization or endorsement from us for any business activities.

2. Disclaimer of Unauthorized Activities

Both the former "OWS (SG) PTE LTD" and its successor entity "ABYSS AI PTE LTD" have engaged in resource procurement activities by falsely claiming affiliation with the OWS Group. We explicitly state that any communications, proposals, agreements, or business conduct undertaken by either entity, under either name, do not constitute legitimate activities of the OWS Group and shall not be construed as such in any context.

3. Trademark and Brand Protection

The OWS name, trademarks, and logo are officially registered in the United States (collectively, "OWS Branding"). Only legally established subsidiary entities of the OWS Group are permitted to use the OWS Branding. Any unauthorized use of the OWS Branding—whether by the former "OWS (SG) PTE LTD" or the current "ABYSS AI PTE LTD"—constitutes potential trademark infringement. The OWS Group reserves the right to take all available legal remedies against such unauthorized use.

4. Advisory and Caution

We strongly urge all partners, suppliers, and customers to exercise strict due diligence when approached by any entity identifying itself as either "OWS (SG) PTE LTD" or "ABYSS AI

PTE LTD." Engaging in business transactions with these entities may expose you to significant commercial, financial, and reputational risks, as their claims of affiliation with the OWS Group are entirely unfounded.

We affirm that any actions, statements, commitments, or representations made by the above-mentioned entities are solely their own. The OWS Group assumes no responsibility or liability whatsoever for any consequences arising from any business dealings with these entities.
